## Re: UE-210795: Puget Sound Energy 2021 Clean Energy Implementation Plan

Dear Ms. Maxwell:

Puget Sound Energy ("PSE") filed its 2021 Clean Energy Implementation Plan ("CEIP") on December 17, 2021 in Docket UE-210795 consistent with the requirements of General Order R-601 in Dockets UE-191023 and UE-190698 and Washington Administrative Code (WAC) 480-100-640. As part of that filing, PSE marked five data files containing Aurora model data as confidential pursuant to WAC 480-07-160 and redacted them in their entirety.

On February 1, 2022, PSE submitted a corrective filing in the same docket, which made technical corrections but did not alter the targets, specific actions or incremental costs in the CEIP period nor any other substantive portions of the CEIP.

Commission staff recently contacted PSE and requested that PSE update the redacted versions of the above-referenced files to provide more description regarding their contents. In response to this request, PSE is hereby refiling each of redacted Aurora files with the following explanation:

[Insert File name] is CONFIDENTIAL per WAC 480-07-160 in its entirety because the file is an electronic model that contains financial and proprietary information. The file contains the tabular results of Aurora model runs, which would be impractical and unduly burdensome to redact; redacting the files would render the model inoperative. Further, the model is governed by an Aurora software license.
