Present provisions are: (see Schedule #65) 16 arrivals and 16 scheduled departures to/from Sea-Tac Airport ending with Run #40 at 11:55 pm from Sea-Tac Airport.

Proposed changes are: (1) Reduce departures from Sea-Tac Airport from 16 to 15 by dropping Run #40 at 11:55 pm; (2) adjusts arrival times to Sea-Tac Airport up to 20 minutes to better fit flight times based on last 6-week reservations; (3) adjusts return times from Sea-Tac Airport to better fit flight arrivals based on the last 6-weeks of actual reservations. All, with the exception of one time, are the same or later.

Indicate below, or attach, an explanation of the reason the company requests permission to file and publish the proposed provisions with less than statutory notice. (1) There has been a severe loss of passengers (461 fewer for Jan. '05 compared to previous year); (2) Severe loss of revenue—approximately \$12,000 (Jan. '05); (3) A severe cash flow crunch has led to delayed payroll, taxes, accounts payable; (4) Passenger loads from Run #40 have diminished to "0" reservations 50% of the time and "1" reservation the other half; (5) The one run loses \$55/day in incremental costs and about \$140/day in total costs.
