## I, Amanda Evans, declare as follows:

- 1. My name is Amanda Evans. I am employed by Qwest Services Corporation as a Customer Account Consultant for the Wholesale Markets organization. My business address is 250 E 2nd S, 5, Salt Lake City, Utah 84111.
- 2. I am providing this Declaration in response to the Petition for Enforcement of Interconnection Agreement filed by TSS Digital Services Inc. and to the Declaration filed by Tom Ellis.
- 3. I prepared the e-mail messages that are attached to Qwest's Answer as Attachment 1, addressed to Linda Farr and Tom Ellis at TSS Digital. I sent those messages on the dates indicated to Linda Farr and Tom Ellis at the e-mail addresses that were in my records for each of those people addresses to which I had previously sent messages. For Linda Farr, the e-mail address was <a href="mailto:hedge@tss.net">hedge@tss.net</a>. For Tom Ellis it was <a href="mailto:hedge@tss.net">tellis@tssdigital.com</a> as shown on the message header. In preparation for this case, I

retrieved those messages from my "sent" folder and forwarded them to Lisa Anderl,

Qwest's in-house attorney in this case. I checked my files and I did not receive an

"undeliverable" or other type of failure message in connection with the delivery of these
e-mails. If I had, I would have attempted to re-send the messages. I did expect TSS

would respond to those e-mails. However, because the interconnection agreement
amendment between the parties has provisions that allow for conversions of circuits even
if customers do not contact us, it was not essential to hear back from TSS on this issue.

4. The e-mail string that is identified as Attachment 3 to Qwest's Answer in this case is a true and correct copy of the e-mail correspondence that I had with Tom Ellis at TSS Digital during August – December 2006 in connection with the conversion of TSS's signaling links. This correspondence was addressed to the same e-mail address as the message in paragraph 3 above. Although Qwest could have converted TSS's signaling links to a tariffed service with the default values established in the tariff, it was to TSS's advantage that Qwest followed up with TSS to obtain the actual percentages that TSS wanted to use, which resulted in a lower billing than the default values would have produced.

I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct.
