Description of amendment: This Agreement is hereby amended by providing the specific terms under which CLEC will receive certain transiting services from Qwest as reflected in Attachment 1 hereto.

The amendment amends the interconnection agreement approved by the Commission on September 3, 2010 in WUTC Docket No. UT-103018.
