Dear Mr. Danner:

As an update to the schedule Puget Sound Energy, Inc. (“PSE”) proposed in its August 1, 2011 filing of PSE’s Draft Request for Proposals from All Generation Sources per WAC 480-107-015 (the “Draft All-Source RFP”), PSE withdraws its request for a 32-day public comment period. After further discussion with Staff of the Washington Utilities and Transportation Commission (“Commission Staff”), PSE believes that it can achieve its objectives to select and negotiate for resources that meet PSE’s identified capacity need beginning in December 2012 and capitalize on the current lower market price environment with the 60-day public comment period provided for in WAC 480-107-015(3)(b), within the 60-day public comment period commencing on the date of filing (August 1, 2011). With this schedule change, PSE requests that the Commission approve the Draft All-Source RFP at the Open Meeting on October 13, 2011, and revises the anticipated RFP schedule as follows:

September 30, 2011	Public comments due
October 13, 2011	Commission Open Meeting
October 18, 2011**	PSE releases final RFP solicitation
