Proposed changes are to add a Special Fuel Surcharge Supplement No. 8 in the amount of: .57%.

1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: August 1, 2012.
2. The proposed changes will expire on: October 31, 2012.
3. The temporary .57% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of May 2012 and June 2012, to be collected from customers as follows:


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of August 2012 and September 2012.

Customers who are billed bi-monthly for services – Current month and one month in advance:

August 2012	August 2012, and September 2012
September 2012	September 2012, and October 2012
