The company requests Commission approval to amend its filed Tariff Number 23 on Less Than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$3.2307 per gallon for the base period to \$3.7075 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 22 in the amount of .12%.


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of August 2012 and September 2012.
