- (1) To solid waste collection, curbside recycling (where noted) and yardwaste services (where noted) for residential property. This includes single family dwellings, duplexes, apartments, mobile homes, condominiums, etc., where service is billed directly to the occupant of each residential unit, and/or
- (2) When required by a local government service level ordinance, solid waste collection, curbside recycling, and yardwaste service must be provided for single-family dwellings, duplexes, mobile homes, condominiums, and apartment buildings of less than 5 residential units, where service is billed to the property owner or manager.

Note 2: Recycling is picked up once per month. Up to 2 -32 gallon cans will be picked up for the regular monthly fee. Additional cans over 2 will be charged as extras. Infrequent customers will be given a sticker or allowance of 1 can per can of garbage service ordered. ©

Note 3: If recycling container contains more than 5% contamination, the container will not be picked up. The customer will then be given the option of removing the contamination or having the container picked up as garbage. ©

Item 100 -- Residential Service -- Monthly Rates (continued from previous page)

Note 4: Customers will be charged for service requested even if fewer units are picked up on a particular trip. No credit will be given for partially filled cans. No credit will be given if customer fails to set receptacles out for collection.

Note 5: The charge for an occasional extra residential bag, can, unit, toter, mini-can, or micro-mini-can on a regular pickup is:

Type of receptacle	Rate per receptacle per pickup
32-gallon can or unit	\$8.20
Mini-can	\$5.50
32 gallon Recycling	\$3.00 (N)

Note 6: Customers may request no more than one garbage pickup per month, on an "on call" basis, at \$9.40 per can/unit and additionally pay \$5.00 for one recycling can pickup. Service will be rendered on the normal scheduled pickup day for the area in which the customer resides. Note: If customer requires service to be provided on other than normal scheduled pickup day, rates for special pickups will apply. (C)

Note 7: The charge for an extra pickup on the regular collection day but not on the regular pickup schedule is \$8.20 per can/unit billed only on the first can and \$8.20 for any additional cans/units.
