Blue Jay Wireless, LLC (Blue Jay or the Company) currently has pending in the above-referenced docket an application to be designated as an eligible telecommunications carrier (ETC) for the purpose of providing federal Lifeline support to low-income consumers in Washington. Through this submission, Blue Jay seeks to address questions raised by Commission staff regarding Blue Jay's Lifeline operations in Hawaii. The information contained in this correspondence is submitted in support of Blue Jay's ETC request. Certain material in this submission fits within the scope of WAC 480-07-160(2)(c) and disclosure would unnecessarily injure the Company's competitive position in the communications market in Washington and elsewhere.


