BACKGROUND

- On December 9, 2013, the Washington Utilities and Transportation Commission (Commission) entered Order 01 denying the request of Reliable Movers, LLC (Reliable or Company) for further mitigation of the penalty assessed against Reliable for the late filing of its annual report and late payment of its regulatory fee. The Commission ordered Reliable to pay the penalty of \$900 no later than December 20, 2013.
- On December 18, 2013, Commission Staff (Staff) contacted the Executive Director and Secretary of the Commission explaining that Reliable had requested to pay the assessed penalty in installments, and that Staff supported the request. Reliable and Staff proposed the following payment schedule:

January 15, 2014	\$225
February 15, 2014	\$225
March 15, 2014	\$225
April 15, 2014	\$225

Reliable and Staff further proposed that if Reliable did not pay the entire \$900 penalty by 5:00 p.m. on April 15, 2014, the Commission was entitled to cancel Reliable's household goods carrier permit.

DISCUSSION

The installment payment schedule Staff and the Company propose is reasonable. The Commission approves that proposal with two modifications. First, in light of the proximity of the first proposed installment payment to the date of this order, the Commission extends the schedule by one month to provide the Company with sufficient notice of the due date of its first payment. Second, Reliable may pay in installments only if the Company pays each installment when it is due. If Reliable fails to timely pay one installment, the entirety of the remaining balance of the assessed penalty will become immediately due and payable, and the Commission may cancel the Company's permit pursuant to Reliable's agreement with Staff.

ORDER

Order 01 is AMENDED as follows:

5 (1) The penalty of \$900 is due and payable to the Commission in installments as follows:

February 14, 2014	\$225
March 14, 2014	\$225
April 15, 2014	\$225
May 15, 2014	\$225

- 6 (2) If Reliable Movers, LLC, fails to pay any installment by 5:00 p.m. on the date that installment payment is due, the unpaid balance will immediately become due and payable without further order by the Commission.
- 7 (3) If Reliable Movers, LLC, fails to pay any portion of the assessed penalty, the Commission may cancel Reliable Movers, LLC's household goods carrier permit by order in this docket.
