#### **BACKGROUND**

On May 20, 2015, InTTec, Inc., d/b/a Visionary Communications, filed with the Washington Utilities and Transportation Commission (Commission) an application for registration and petition for classification as a competitive telecommunications company in Docket UT-140240. The application and petition do not comply with the rules set forth in WACs 480-120 and 480-121.

# FINDINGS AND CONCLUSIONS

InTTec, Inc., d/b/a Visional Communications, did not provide a Unified Business Identifier (UBI) number nor are they registered as a corporation with the Secretary of State's office. It's application and petition are therefore not in compliance with the rules set forth in WACs 480-120 and 480-121 and should be rejected.

## **ORDER**

- THE COMMISSION REJECTS the application and petition of InTTec, Inc., d/b/a Visionary Communications, in its entirety. This Order does not preclude InTTec, Inc., from filing a later application and petition for registration as a competitive telecommunications company.
- The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
