Cascade Natural Gas Corporation (Cascade or Company) hereby submits supplementary information in support of its Cascade's Annual Conservation Achievement Report for calendar year 2016, submitted May 31, 2017, in Docket No. UG-152286.

As adopted by Order No. 04 in UG-152286, an advisory committee consisting of interested parties was formed to provide oversight of the Company's conservation programs. Cascade is required to provide drafts of its conservation-related, regulatory filings to the advisory group in advance of making a submission with the Washington Utilities and Transportation Commission (Commission). The advisory group reviewed Cascade's Annual Conservation Achievement Report, and Commission Staff informally issued the Company a number of questions about the report.
