Recommendation

Take no action, thereby allowing the tariff revisions filed by Estates Water Systems, Inc., on June 6, 2018, as revised on July 13, 2018, and July 18, 2018, to become effective July 27, 2018, by operation of law.

Discussion

On June 6, 2018, Estates Water Systems, Inc. (Estates Water or company), filed with the Utilities and Transportation Commission (commission) a proposed general rate increase that would generate \$55,000 (56 percent) additional annual revenue. The company's reason for the increase is many operating costs, since their last increase 21 years ago, have risen to include taxes, insurance, Department of Health operating permit fees, water quality testing and repair parts. The proposed effective date is July 27, 2018. The company serves 346 residential customers near Sequim in Clallam County. The company's last rate increase was effective July 10, 1997.

The tariff revisions in Tariff WN U-3 include, new ancillary charges for a Disconnection Visit, Service Visit, Late Payment Charge, Account Set-up Charge, NSF Charge, and Water Availability Letter Charge.

This filing changes the current rate design by adding tiered usage blocks and usage rate charges. Additionally, a 2-inch meter charge is being established. Usage blocks and rates will provide more accurate water usage data and help the company promote water use efficiency.

Customer Comments

On June 5, 2018, the company notified its customers of the proposed rate increase by mail. The commission received no comments.
