4 **Q. Please state your name, business address, and position with Puget Sound**
5 **Energy.**

6 A. My name is Daniel A. Doyle. My business address is 10885 NE Fourth Street,
7 P.O. Box 97034, Bellevue, WA 98009-9734. I am Senior Vice President and
8 Chief Financial Officer of Puget Sound Energy (“PSE”).

9 **Q. By whom are you employed and in what capacity?**

10 A. I am PSE’s Senior Vice President and Chief Financial Officer.

11 **Q. What are your duties as Senior Vice President and Chief Financial Officer?**

12 A. As Senior Vice President and Chief Financial Officer, I have the overall
13 responsibility for the financial management and financial health of PSE, which
14 includes communicating with the financial community, overseeing financial
15 strategy and financing programs, and overseeing PSE’s financial regulatory
16 strategy before the Washington Utilities and Transportation Commission and
17 before the Federal Energy Regulatory Commission.

18 **Q. Briefly describe your education and relevant employment experience.**

19 A. I have a Bachelor of Arts degree in Accounting from Michigan State University. I
20 also have a Masters of Business Administration in General Management and
21 Technology from Rensselaer Polytechnic Institute in Troy, New York.

1 I joined PSE on November 28, 2011, with more than 25 years of experience in the
2 utility and electric transmission industry. Prior to joining PSE, I was President and
3 Chief Executive Officer of Wisconsin Sports Development Corporation in
4 Madison, Wisconsin. From October 2000 to July 2009, I served as Vice President,
5 Chief Financial Officer, and Treasurer of American Transmission Company LLC
6 (“ATC”). As a Member of the leadership team and Officer at ATC’s first multi-
7 state, transmission-only utility, I was responsible for overseeing the financial,
8 information technology and human resource functions.

9 Prior to ATC, I was employed by Alliant Energy Corporation (“Alliant Energy”)
10 and its various predecessor companies. I held various positions at Alliant Energy,
11 including Controller and Treasurer, Vice President of Finance, Vice President of
12 Power Production and Wholesale Services, and Vice President of Manufacturing
13 and Energy Portfolio Services. During my tenure at Alliant Energy, I was
14 responsible for accounting and financing matters and strategic financial planning
15 matters, including merger analysis, dividend policies and asset rationalization
16 initiatives. I also managed approximately 5,000 megawatts of generating facilities
17 as well as the energy trading functions. In January 2000 I became Alliant
18 Energy’s Vice President and Chief Accounting and Financial Planning Officer.

19 Prior to joining Alliant Energy, I served as a Senior Audit Manager of Arthur
20 Andersen & Co. for eight years and as Controller of Central Vermont Service
21 Corp. for four years. I am a certified public accountant and have personally
22 testified on a variety of matters in utility regulatory proceedings in Vermont, New
23 Hampshire, Iowa, and Wisconsin. I have also testified before the Federal Energy

Regulatory Commission. In addition to providing testimony as described above, I have served clients in regulatory proceedings before the Federal Energy Regulatory Commission and the Kentucky, Indiana, and Illinois utility commissions.
