Consistent with the requirements of General Order R-601 in Dockets UE-191023 and UE-190698 and WAC 480-100-640, Puget Sound Energy (“PSE”) is pleased to submit its 2021 draft Clean Energy Implementation Plan (“CEIP”). PSE is filing this draft CEIP on October 15, 2021 pursuant to the deadline established in Order 01 Granting Petition for Exemption and Motion for Continuance Subject to Conditions in Docket UE-210571 (“Order 01”). The attached draft CEIP is also posted at cleanenergyplan.pse.com and available for download.

While PSE worked hard to ensure a thorough and comprehensive draft filing, it is also actively working to incorporate new and updated information for the final CEIP. For example, we anticipate making updates to the draft biennial conservation plan inputs and transmission cost inputs. Additionally, the following elements are still under development and will be included in the final CEIP:

- Chapter 3, Section on Baseline Calculations for Customer Benefit Indicators and related content in Appendix H.
- An appendix providing a summary of advisory group comments [pursuant to WAC 480-100-655(1)(i)].

Over the next month, PSE will continue consultation with customers, stakeholders and advisory groups to obtain input on the draft CEIP. Additionally, an online open house to gather public input on the draft CEIP at pse.com/plan, will launch on Monday, Oct. 18 and be available through Friday, Nov. 12. Feedback from the online open house and upcoming advisory group

meetings will be considered and incorporated into the final CEIP, which PSE will file on December 17, 2021, pursuant to Order 01.
