Puget Sound Energy's Electric Tariff Revision – Do Not Redocket

Puget Sound Energy ("PSE") hereby submits in connection with Docket UE-250725 the following revised tariff sheets as substitutions for the tariff sheets that accompanied its September 22, 2025, filing made under Advice No. 2025-39.

The primary purpose of this substitution is to allow additional time for Commission Staff to complete their review of this filing and extend the effective date from November 1 to November 21, 2025. This substitution also corrects a scrivener's error in the revision number of Sheet Nos. 307-A and 307-B.

In addition, PSE respectfully requests that the Commission grant a waiver of its rule WAC 480-100-178(1)(e) Billing Requirements and Payment Date regarding, "Show the beginning and ending meter readings for the current billing period...the bill need not include interval readings..." based on feedback from Commission Staff. One of the topics that was learned

through the initial pilot phase of these new optional services is that customers who are billed on interval data (which is how time-of-use charges are calculated and billed) do not have start and end reads on their bill statements. This is true for all optional rates billed using interval data. To give an example of existing tariff language, PSE's electric Schedule 558 General Service for Electric Vehicle Fleet Charging is also billed using interval data and the tariff schedule contains similar language. From Schedule 558, Sheet No. 558-A, "The Customer understands that the monthly bill will include interval readings but that by the nature of this optional service may not display beginning and ending meter readings for the billing period." Similarly, new language was proposed to clarify this in the time-of-use tariff schedules in this tariff filing.

The Company has met customer notice requirements under WAC 480-100-194 and has made its Notice Verification filing under WAC 480-100-198. In addition, the Company also intended to email customers following the approval of this tariff filing with supplemental information. To help customers understand their electric service schedule options, PSE will provide additional information to customers about this tariff filing prior to its effective date. The content of the supplemental email is being shared with Commission Staff.

The tariff sheets described herein reflect the original issue date of September 22, 2025, and revised effective date of November 21, 2025. Posting of proposed tariff changes, as required by law and the Commission's rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193. Public notice pursuant to WAC 480-100-194 was previously provided.
