## SECOND ADDENDUM TO AGREEMENT CONCERNING OPERATION OF WASHINGTON DATA DISTRIBUTION CENTER

THIS SECOND ADDENDUM to the Agreement Concerning Operation of Washington Data Distribution Center ("DDC Agreement") is entered into this day of how of 1996, by and among the Washington Exchange Carrier Association ("WECA"), a Washington nonprofit corporation, US WEST Communications, Inc. ("USWC"), a Colorado corporation, GTE Northwest Incorporated ("GTENW"), a Washington corporation, and United Telephone Company of the Northwest ("United"), an Oregon corporation.

#### RECITALS

- 1. WECA, USWC, and GTENW have entered into the DDC Agreement dated the 16th day of May, 1996. The DDC Agreement contemplates that other telecommunications companies will become parties to that Agreement.
- 2. United has filed with the Washington Utilities and Transportation Commission to become a primary toll carrier. It has delivered notice to WECA that it will withdraw from WECA upon approval by the Washington Utilities and Transportation Commission of United to operate as a primary toll carrier. United desires to participate in the Data Distribution Center as a primary toll carrier ("PTC"), providing intraLATA toll within the state of Washington.
- **NOW, THEREFORE,** in consideration of the mutual promises and benefits contained herein, the parties hereto agree as follows:

#### AGREEMENT

1. At such time as United is approved by the Washington Utilities and Transportation Commission to become a PTC by routing 1+ intraLATA traffic, in whole or in part, to itself, United shall participate in the DDC as a PTC and the allocation of WECA's charges under Paragraph 4.6 of the DDC Agreement shall be made among the PTCs (United, USWC, and GTENW) in proportion to each PTC's messages processed by the Data Distribution Center relate to the total messages of all the PTCs processed by the Data Distribution Center. For this purpose, a PTC's messages mean those messages that apply to intraLATA toll traffic carried by that PTC.

By way of illustration, the following is an example of the allocation of costs:

- 2. In addition to all other responsibilities of a PTC contained in the DDC Agreement, United shall perform all duties and responsibilities contained in Article 7 DDC Operations GTENW Responsibilities, Section 3.1 Receipt of Records, and Section 8.1 WECA Audits, which for purposes of this Addendum only shall be amended to substitute United for GTENW.
- **3.** Section 16.9 <u>Notices</u> is amended to add the following notice address at the end of the section:

- **4.** Except to the extent that the DDC Agreement has been amended by Paragraphs 1, 2, and 3, above, the DDC Agreement shall remain in full force and effect and by this Addendum United shall be treated as and shall become a party to the DDC Agreement, upon approval by the Washington Utilities and Transportation Commission for United to operate as a PTC.
- 5. This Addendum may be executed in two or more counterparts, each of which will be deemed an original, but all of which together constitute one and the same instrument. This Addendum may be executed by facsimile, which will be deemed an original signature.
