ALLIANCE OF WESTERN ENERGY CONSUMERS' MOTION FOR PARTIAL WAIVER

Pursuant to WAC § 480-07-375, the Alliance of Western Energy Consumers ("AWEC") respectfully moves the Commission to exercise its discretion and waive the timing requirement in Section 6.2 of the Washington Extended Interim Participatory Funding Agreement ("Extended Interim Agreement") that requires a party requesting a Fund Grant to file its Petition for Case Certification ("Petition") and Notice of Intent to Request Fund Grant ("Notice") on or before the date of the prehearing conference unless the Commission has designated an alternative time.

Because the Commission has not designated an alternative time, AWEC's Petition and Notice in the above-referenced docket would have been due on or before January 9, 2024. However, AWEC is filing its Petition and Notice concurrently with this Motion, approximately five weeks after the prehearing conference in this case. As indicated by AWEC's proposed budget in this case, filed concurrently with its Petition and Notice, AWEC conferred with The Energy Project and NW Energy Coalition, which have utilized PacifiCorp's Customer

Given the proximity to the prehearing conference, the early stages of this case and the lack of current demand on PacifiCorp's Customer Representation Sub-Fund, AWEC does not believe that any other party is prejudiced by AWEC's delayed request. For these reasons, AWEC respectfully moves the Commission to waive the timing requirement in Section 6.2 of the Extended Interim Agreement and accept AWEC's Petition and Notice in this proceeding.
