**NOTICE OF REQUIREMENT TO FILE ADDITIONAL STATUS REPORT(S)
(By Friday, September 4, 2009)**

RE: *In the Matter of Determining the Proper Carrier Classification of Glacier Recycle, LLC; Hungry Buzzard Recovery, LLC; and T&T Recovery, Inc.,*
Docket TG-072226

TO ALL PARTIES:

On October 23, 2008, the Washington Utilities and Transportation Commission (Commission) suspended the procedural schedule in this docket. In November and December 2008, the Commission held two status conferences regarding the parties' progress toward a settlement and the potential for the Commission's rulemaking proceeding in Docket TG-080591 to influence the ultimate outcome of this case. On December 8, 2008, the Commission allowed the procedural schedule to remain suspended and issued a Notice of Requirement to File Status Report(s) no later than Friday, April 10, 2009.

On April 8, 2009, Commission Staff filed its status report and expressed a belief that the Commission's rulemaking proceeding in Docket TG-080591 will likely resolve the remaining issues in this matter. Commission Staff recommended that the procedural schedule remain suspended and that a status conference be scheduled in three to four months.

On April 10, 2009, two of the intervenors in this matter, Waste Management of Washington, Inc., and Murrey's Disposal Company, Inc.,¹ filed their status reports. Both concurred with Staff that no further action be taken in this docket for several additional months. No other parties filed status reports.

¹ Counsel for Murrey's Disposal Company, Inc., also represents Island Disposal, Inc., Waste Connections of Washington, Inc., Allied Waste of Lynnwood, and Allied Waste of Bellevue. The above-noted status report represents the position of all five of these intervening companies.

The undersigned ALJ accepts the recommendation that the procedural schedule remain suspended and an additional status update be required later this year.

THE COMMISSION GIVES NOTICE THAT the parties must file a joint additional status report (or, in the alternative, individual reports from each² party) regarding:

- (a) the impact of the Commission's solid waste rulemaking proceeding in Docket TG-080591 toward resolution of the remaining issues presented in this docket; and**
- (b) the need to schedule another status conference in this proceeding, set a new deadline for a third status report, or re-set the matter for hearing later in Fall 2009.**

The status report(s) must be filed no later than Friday, September 4, 2009. In the interim, any party may request that a status conference be scheduled at an earlier date.

THE COMMISSION REITERATES THAT the Findings of Fact and Conclusions of Law set out in Order 06 remain in effect and govern the parties to this case.
