Dear Mr. King:

Per paragraph 55 of the settlement agreement approved in Puget Sound Energy's ("PSE") 2017 general rate case in Dockets UE-170033 and UG-170034, instead of quarterly, PSE will now file it's environmental remediation reports annually each April 30th. This is the first such annual filing that PSE is required to make under the settlement agreement.

Additionally, per paragraph 54 of the settlement, on February 13, 2018, PSE and Commission Staff commenced discussions related to determining a methodology for assigning insurance recoveries. PSE and Commission Staff are continuing to work through finalizing the methodology.

PSE worked with Commission Staff to develop the format of the enclosed report. During the development of the report, Commission Staff requested additional information to support a transaction related to the City of Olympia v. PSE Plum Street site. Therefore, PSE is also submitting with this letter the supporting information as requested by Commission Staff.
