TO ALL PARTIES:

Through a telephone conference and electronic mail on Thursday, December 22, 2005, the parties requested changes to the current procedural schedule, including changes to the hearing schedule. **The parties' joint request for a scheduling change is granted. To accommodate the requested changes, the hearings will not begin until Wednesday, January 11, 2006, at 1:30 p.m., and the hearings scheduled for Monday and Tuesday, January 9 and 10, 2006, are canceled.**

Parties must adhere to the following modified procedural schedule:

**January 4, 2006:
(Wednesday)**

Electronic submission and service of witness lists, order of witnesses, and cross-examination estimates. Parties must also indicate witnesses for whom the parties have agreed to waive cross-examination. **Please Note: Parties may use the commission's Web Portal to submit these documents, but must also send a courtesy e-mail copy to the presiding administrative law judges.** (*Moved from Friday, December 30, 2005*).

**January 5, 2006:
(Thursday)**

Electronic submission of exhibit lists identifying cross-exhibits and correcting the list of prefiled exhibits. **Please Note: Parties may use the commission's Web Portal to submit these documents, but must also send a courtesy e-mail copy to the presiding administrative law judges.** (The bench will distribute to all parties by close of business on January 3, 2006, a draft list of all prefiled exhibits). (*Moved from Tuesday, January 3, 2006*).

- January 6, 2006:
(Friday)** Parties must file with the commission an original and 11 sets of proposed cross-examination exhibits for each witness (individual exhibits must be separated by an index sheet and every page and the index must be three-hole punched (oversized holes preferred). **Please Note: Parties may use the commission's Web Portal to submit these documents, but must also send a courtesy e-mail copy to the presiding administrative law judges.** (*Moved from Wednesday, January 4, 2006.*)
- January 9, 2006:
(Monday)** **Prehearing conference, 1:30 p.m., Room 206, Commission Main Hearing Room, Olympia.** This conference will be held only to resolve any final prehearing issues. Parties must notify the administrative law judges and all parties by 9 am on January 9, 2006, if there is a need for the conference. (*Prehearing conference rescheduled from Wednesday, January 4, 2006. NOTE: Evidentiary hearings scheduled for January 9 and 10, 2006, are canceled.*)
- January 11, 2006:
(Wednesday)** **Evidentiary hearings begin at 1:30 p.m., and will continue through January 20, 2006.** Please Note: The commission will observe the Martin Luther King Jr. holiday on January 16, 2006, and no hearing will held that day.
- January 23-24, 2006:** The commission will continue the evidentiary hearings on these two additional days, if necessary, to complete the evidentiary hearing.
