TO ALL INTERESTED PERSONS:

On March 20, 2013, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider possible additions or modifications to certain sections in Washington Administrative Code (WAC) 480-07, the Commission's procedural rules.

The Commission received written comments on its CR-101 on May 21, 2013, and its draft rules for Part I of this chapter, WAC 480-07-010 through 180, on December 20, 2013, and October 23, 2014.

The Commission staff has now developed draft rules for review and comment by interested persons for Part III of this chapter titled Adjudicative Proceedings, Subpart A: Rules of General Applicability, WAC 480-07-300 through 498.
