Dear Mr. Danner:

In compliance with the terms of the Partial Settlement Stipulation RE: Service Quality, Meter and Billing Performance, and Low-Income Bill Assistance in consolidated Docket Nos. UE-072300 and UG-072301 Order 12 ("Order 12") and the terms of the Partial Settlement RE: Meter and Billing Performance Standards in consolidated Docket Nos. UE-111048 and UG-111049 in Order 08 ("Order 08"); Puget Sound Energy, Inc. ("PSE") submits an original and twelve copies of PSE's Meter and Billing Performance Quarterly Filing for the period ended June 30, 2012.

The layout and elements of this report are consistent with the draft quarterly meter and billing report outline reviewed and discussed with the Commission Staff on June 7, 2012. During the June 7, 2012 telephone conference call, PSE and the Commission staff ("Staff") discussed the reporting format and requirements for quarterly reporting periods June 30, 2012, through June 30, 2013, and zero consumption customer notifications under Order 08. Staff did not propose any specific changes to the draft quarterly report outline.

In addition to meeting the meter and billing performance standards and reporting requirements outlined in Order 08 and Order 12, this report also documents PSE's efforts regarding the one-time investigation requirement of meters with zero consumption for 365 consecutive days to be investigated during the period June 1, 2012 through May 31, 2013. PSE believes that inclusion of reports on PSE's ongoing efforts in investigating and correcting the 365-day zero consumption meters will facilitate Staff's review of PSE's investigation process and allow PSE to address Staff's concerns and suggestions prior to the conclusion of the one-time investigation.
