

Dear Mr. Johnson:

At the recessed open meeting on Monday, November 5, 2018, the Joint Applicants represented, in response to a question from Chairman Danner, that the Joint Applicants expected the Federal Energy Regulatory Commission (FERC) to soon issue an order on the sale of all of the membership interests in Puget Holdings LLC held by MIP Padua Holdings, L.P. and Padua MG Holdings LLC and the acquisition of such interests by Alberta Investment Management Corporation Docket, British Columbia Investment Management Corporation, OMERS Administration Corporation, and PGGM Vermogensbeheer B.V. (the "Proposed Transactions"). This letter is to inform the Commission that, shortly after such representation was made, FERC issued an order concluding that the Proposed Transactions are consistent with the public interest and authorizing the Proposed Transactions, subject to the customary conditions, pursuant to sections 203(a)(1) and (2) of the Federal Power Act, 16 U.S.C. § 824b.

Additionally, this letter confirms that each of OMERS Administration Corporation and PGGM Vermogensbeheer B.V. has made its respective filing with the Committee on Foreign Investment in the United States.


