## NOTICE OF BENCH REQUEST (Response due by Friday, February 18, 2011, at 3:00 p.m.)

RE: In the Matter of the Joint Application of Qwest Communications International Inc. and CenturyTel, Inc. for Approval of Indirect Transfer of Control of Qwest Corporation, Qwest Communications Company LLC, and Qwest LD Corp., Docket UT-100820

The Washington Utilities and Transportation Commission (Commission) seeks information in the form of the following bench request from Qwest Communications International Inc. (QCII), CenturyTel, Inc. (collectively with QCII, Joint Applicants), and tw telecom.

On February 10, 2011, Joint Applicants and tw telecom filed a Settlement Agreement which the parties' claim resolves all of tw telecom's "objections, issues and proposed conditions related to the [merger]."<sup>1</sup> In the Settlement Agreement, Joint Applicants commit to "continue to provide IP peering consistent with the terms and obligations of the Bi-lateral Peering Agreement,"<sup>2</sup> as well as to "continue to offer an Annual Incentive Plan (AIP) program to tw telecom through December 31, 2013."<sup>3</sup> Neither the Bi-lateral Peering Agreement nor the Annual Incentive Plan has been provided to the Commission. On February 14, 2011, tw telecom submitted a letter seeking to

withdraw from the proceeding because of the settlement it reached with Joint Applicants.

In past merger proceedings, including the CenturyLink – Embarq merger proceeding, the Commission has required transparency with regard to any agreements (side-agreements) which are related to a party's participation or decision to withdraw from a proceeding.<sup>4</sup>
