We have just discovered that the paper (but not electronic) version of Puget Sound Energy's Inc.'s General Rate Case, which was filed with the Commission on April 5, 2004, contains five pages of material that is not related to the General Rate Case and was inadvertently included in the filing. Specifically, at the end of Mr. Charles Cicchetti's prefiled direct testimony, Exhibit \_\_\_\_ (CJC-1T), which is 50 pages long, there are five pages of material (an email and referenced attachment) that have no relation to Mr. Cicchetti's testimony or, indeed, to Puget Sound Energy, Inc.
