On November 7, 2001, the Commission filed with the Code Reviser a Notice of Proposed Rulemaking (CR-102) for rules relating to Registration, Competitive Classification, and Initial Price Lists of Telecommunications Companies, Chapter 480-121 WAC; Prepaid Calling Services, WAC 480-120-052; and Protection of Customer Prepayments, WAC 480-120-058.

The public hearing to consider adoption of the proposed rules is scheduled for 9:30 a.m., Wednesday, December 12, 2001, at the Commission's open meeting. The adoption hearing will be changed and will be held at **1:30 p.m., on Wednesday, January 9, 2002.**

NOTICE is hereby given of the opportunity to attend the public hearing and make oral comments about the proposal for the adoption of the proposed rules at 1:30 p.m., Wednesday, January 9, 2002. This public hearing will be held in the Commission's Hearing Room, Second Floor, Chandler Plaza, 1300 S. Evergreen Park Drive, S.W., Olympia, Washington.

The Commission Staff registration rule team has completed a draft of proposed rules that it intends to present for adoption on January 9, 2002. To prepare this draft, the Commission Staff has considered all oral and written comments received to date. Your comments on this recent draft of the proposed rules are welcomed. Any comments received will be taken into account before Commission Staff presents the rules to the Commission for adoption.

NOTICE is also hereby given of the opportunity to submit written comments on the proposed rules to the Commission by filing with the Commission Secretary either by electronic transmission as described below, or by physical delivery to 1300 S. Evergreen Park Drive S.W., P.O. Box 47250, Olympia, Washington, 98504-7250, no later than 5:00 p.m., Friday, December 21, 2001. The draft rules are available for inspection on the Commission's web site at www.wutc.wa.gov/991922. The Commission will send you a paper copy of the draft rules or will send the proposal via electronic mail, if you ask.
