- On June 7, 2005, Puget Sound Energy, Inc. (PSE) filed certain tariff revisions directly affecting PSE's Tariff Schedule 95, Power Cost Adjustment Mechanism (PCA), which would make adjustments to the Power Cost rate to reflect changes in the Company's overall normalized power supply costs.
- The Commission suspended the operation of the tariff revisions by Order entered June 15, 2005, pending an investigation and hearing concerning the proposed changes and whether they are just and reasonable. PSE requests by motion that the Commission set an expedited procedural schedule in this proceeding. PSE also requests by motion that the Commission enter its standard form of Protective Order, amended to include provisions concerning the designation of documents as "Highly Confidential." WAC 480-07-420 and -423.
- Hearing in this matter is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of electric utilities. Statutes involved, in addition to those previously cited,

include those within chapters 80.01, 80.04 and 80.28 RCW relating to rates, including but not limited to RCW 80.01.040, RCW 80.04.020, RCW 80.28.020, RCW 80.28.030, RCW 80.28.070, RCW 80.28.090, and RCW 80.28.100. Rules involved include those within chapters 480-07 and 480-100 WAC.

- The ultimate issues include whether the proposed tariff revisions are just, fair, reasonable, sufficient, and in the public interest. The ultimate issues also include whether PSE's current power cost rate on file and in effect with the Commission is just, fair, reasonable, and sufficient. These issues include consideration of alternative rate design or structure. In accordance with the provisions of RCW 80.04.130, PSE bears the burden of proof to show that the proposed tariff revisions are just and reasonable.
- NOTICE IS GIVEN That the Commission has determined that good cause exists for this matter to be heard on shortened notice in accordance with RCW 34.05.434 and WAC 480-07-440.
- NOTICE IS GIVEN That a prehearing conference in this matter will be held at 1:30 p.m., on Wednesday, June 22, 2005, in the Commission's Hearing Room, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
- The purpose of the prehearing conference is to take interventions, consider all pending motions, establish dates for distribution of the Company's direct evidence and workpapers and other scheduling matters, consider formulating the issues in the proceeding and to determine other matters to aid in its disposition, as specified in Chapter 480-07 WAC.
- Petitions to intervene should be made in writing prior to the hearing date or made orally at the hearing. The Commission prefers written petitions.

 Appearances will be taken at the prehearing conference. If any party or witness needs an interpreter or other assistance, please fill out the form attached to this

notice and return it to the Commission. The time and place for the evidentiary hearings will be set at the prehearing conference or by later written notice.
