1 PROCEEDINGS JUDGE BERG: This is a public hearing in 3 Docket Number UW-000405 before the Washington Utilities 4 and Transportation Commission. This case is captioned 5 the Washington Utilities and Transportation Commission, Complainant, versus American Water Resources, Inc., 7 Respondent. 8 Today's date is December 6, 2000. We are 9 meeting in the Commission's main hearing room at its 10 headquarters in Olympia pursuant to good and sufficient 11 notice served on interested persons on November 22, 12 2000. 13 My name is Larry Berg. I'm an Administrative 14 Law Judge with the Commission.    surcharge was approved by the Commission on April 28,
   1999, and it will expire May 1, 2004, or upon recovery
4 of the costs of improvements, whichever occurs first.
              AWR is seeking to extend the surcharge period
6 to September 1, 2005, to recover the actual costs
7 incurred in making those upgrades. The Commission has
8 already determined that the purpose for the surcharge is
9 reasonable and consistent with the public interest. All
10 AWR customers presently pay an additional $4.54 on their
11 monthly water bill due to the surcharge. The
12 Commission's water section staff is participating as a
13 party in this case, and they are presently conducting
14 discovery regarding relevant issues. Monthly rates will
   not go up as a result of this case, but the $4.54
   surcharge may extend for an additional 16 months if

   approved.
