- 1 Certificate of Public Convenience and Necessity No. G-21, stands in the name of Robert J. Pellegrini, d/b/a Upper Valley Disposal, and authorizes the service therein set forth.
- *2* Certificate of Public Convenience and Necessity No. G-169 stands in the name of Couse's Sanitation & Recycle, Inc., and authorizes the service therein set forth.
- *3* Joint Application GA-79172 has been filed requesting authority to transfer a portion of rights under said Certificate No. G-21 from Robert J. Pellegrini, d/b/a Upper Valley Disposal, to Couse's Sanitation & Recycle, Inc., holder of Certificate No. G-169.
- 4 The portion of rights to be transferred is as follows:

Sections 23, 24, 25, 26, 35, and 36, in T38N, R30E; and Sections 1, 2, 10, 11, and 12 in T37N, R30E.

5 It appears that the transfer of rights as herein requested will not be detrimental to interests of the public and that the transferee is fit, willing and able to conduct the involved transportation service.

ORDER

- 6 WHEREFORE, IT IS ORDERED That the application herein be, and the same is hereby granted and contingent upon the applicant transferee having complied with the provisions of chapter 81.77 RCW and the rules relating to solid waste companies, that said Certificate No. G-21 standing in the name of Robert J. Pellegrini, d/b/a Upper Valley Disposal, be amended as per the attached Appendix A; and that Certificate No. G-169 standing in the name of Couse's Sanitation & Recycle, Inc., be amended as per the attached Appendix B.
- 7 The Commission further orders that the tariff filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this order.
- 8 All parties interested should take notice that the Commission in granting authority for the transfer of rights under a solid waste certificate does not necessarily approve the amount involved in the transaction, nor does it bind itself to recognize such amount in placing a value for ratemaking purposes on the property of the certificate holder.
