- On September 8, 2003, Aleksandr D. Gorshenin, d/b/a A Reliable Delivery Service, filed an application for permanent household goods carrier authority in the state of Washington under the provisions of RCW 81.80 and WAC 480-15, rules relating to household goods carriers.
- The application appeared on the September 22, 2003, application docket. One comment protesting the application was received on behalf of Clancy's Transfer & Storage, Inc., holder of Household Goods Carrier Permit No. HG-11051. It requests that the Commission deny the permit because the applicant has operated illegally in the past and that the applicant would not be a positive addition to the community.
- The protest should be denied. An applicant's assurance of future compliance with the Commission rules and laws may be credible, not withstanding past unauthorized operations, when the applicant has discontinued unauthorized hauls and applied for the necessary authority. See Order M. V. No. 140097, In re T & T Milk Transport, Inc., App. No. E-19755 (September 1989). The Commission received no consumer complaints regarding the service provided by the applicant during its temporary operations, nor did customer surveys reflect poor service quality.
- The applicant has conducted temporary operations, as required under the provisions of WAC 480-15-280(1), and has met the criteria established in

WAC 480-15-330 for obtaining permanent authority. The applicant is fit, willing and able to provide the proposed service and it appears that the permanent authority requested will not be detrimental to the interests of the public.

The Commission, having considered the application and being fully advised, finds that the existing service is needed to satisfy the public convenience and necessity and it would be in the public interest to grant the application pursuant to the provisions of WAC 480-15-330.

ORDER

- IT IS ORDERED That application P-79219, of Aleksandr D. Gorshenin, d/b/a A Reliable Delivery Service, for permanent household goods authority in the state of Washington is granted.
- 7 IT IS FURTHER ORDERED That Permit No. HG-61091 authorizing temporary operations be reissued as unrestricted permanent household goods authority in the state of Washington.
