

BILLING DISPUTE

This Billing Dispute Settlement Agreement ("Agreement") is between Qwest Corporation, including its affiliates ("QC"), Asotin Telephone Company ("Asotin"), Lewis River Telephone Company ("Lewis River") and McDaniel Telephone Company ("McDaniel"). Asotin, Lewis River and McDaniel are collectively referred to as the "Independent Companies". QC and the Independent Companies are collectively referred to as the "Parties" and may be referred to individually as a "Party." 




