- 1 Certificate of Public Convenience and Necessity No. C-1079 stands in the name of Edward Masters, d/b/a Orcas Island Shuttle, and authorizes passenger and express service as therein set forth.

- 2 On January 8, 2007, a joint application was filed for authority to transfer all rights under said Certificate No. C-1079 Edward Masters, d/b/a Orcas Island Shuttle, to Orcas Island Shuttle, LLC, d/b/a Orcas Island Shuttle.

- 3 The application appeared on the February 9, 2007, application docket and was unopposed.

- 4 It appears that Orcas Island Shuttle, LLC, d/b/a Orcas Island Shuttle, is able and willing to furnish all services necessary under Certificate No. 1079, and that the all rights transfer to Orcas Island Shuttle, LLC, d/b/a Orcas Island Shuttle, as requested will not be detrimental to the interests of the public.

ORDER

- 5 WHEREFORE, IT IS ORDERED That the application herein be and the same is hereby granted, conditioned upon compliance by all parties concerned with the law and rules governing auto transportation companies, and subject to any legal claims, liens, or equities.

- 6 IT IS FURTHER ORDERED That Certificate of Public Convenience and Necessity No. C-1079 standing in the name of Edward Masters, d/b/a Orcas Island Shuttle, be amended as per the attached Appendix A.

- 7 All parties interested should take notice that the Commission in granting authority for the transfer of rights under a certificate does not necessarily approve the amount involved in the transaction, nor does it bind itself to recognize such amount in placing a value for rate-making purposes on the property of the certificate holder.
- 8 The Commission further orders that the tariff and time schedule filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this order.
