## Greetings:

We are sitting on the end of a very short fuse. Here are the facts:

On May 10, Rosario Utilities (RU) filed for a rate increase with the Washington Utilities and Transportation Commission (WUTC). They requested to raise our annual revenue by \$148,095 or 62%. The last change in rates became effective August 1, 2002.

The proposed rates would increase the average bill (4,000 gallons/month) by approximately \$25.30. The rate increase is needed to offset higher operating costs and to capitalize capital improvements completed, but not totally paid by the surcharge (the one that was eliminated in January of 2007).

If approved, the new rate would become effective July 1, 2007.

But here's the kicker: the WUTC's open meeting to deal with the requested increase, is tentatively scheduled at 9:30am on May 23rd in Olympia. That's very short notice for a meeting for something which has this magnitude of effect. On the 23rd, the commission will take comments, but will rule on the request at its open meeting on June 6th, also in Olympia.

What we need from ALL of you is to CALL, WRITE, e-mail, etc., the WUTC and request the following:

1---the meeting of the 23rd should take place here on Orcas, particularly because of the short notice given all of us about the proposed rate increase. We (RPOA, Vusario, OHA) would pay to get the three commissioners, a 'judge' and a recording secretary to Orcas for that meeting.

2---because of the shortness of notice (and Mothers' Day being in the middle of it all), we have several questions about the audit of expenses and proposed (company adjusted) budget figures shown by RU. You can get a copy of this from Chris Vierthaler at RU. Please stop by in person and get a copy of the RESULTS OF OPERATION STATEMENT
