PASSENGER RULES

Adult fares: Published fares are adult fares and apply to passengers who have reached or passed their 13th birthday.

Animals: Service dogs traveling with sight or hearing-impaired passengers will be carried free of charge. The dogs will not be permitted to occupy a seat, but must lie or stand at the feet of the passenger. Non-Service Dogs will be carried at the fare of an adult passenger. All dogs must be on a leash or caged.

Objectionable passengers: This Company reserves the right to refuse to transport persons under the influence of drugs or alcohol, or who are incapable of taking care of themselves, or whose conduct or behavior may be objectionable to other passengers. The carrier also reserves the right to refuse carriage of any materials that the carrier considers unsafe and not in the best interest of the passengers.

Schedule maintenance: Carrier will not be liable for delays caused by accidents, breakdowns, bad conditions of the roads, snow storms or other conditions beyond the control of the carrier and does not guarantee arrival at, or departure from, any point at any specific time.
