Hello, Rayne.

Please forgive me if I made a mistake on the submission of my previous correspondence. I was under the impression emailing it the [consumer@utc.wa.gov](mailto:consumer@utc.wa.gov) email should've been adequate. I apologize.

I'm curious though, are you trying to help me or harm me here? I'm new to this, so I'd appreciate some guidance. Are you the one who is to respond to me in the way that you are? WAC 480-07-380 seems to get the closest in describing the type of responses I've been getting, but it says that only a party may move to do so. Are you considered a party to this claim or case?

In addition, I'm unclear how I've still failed to "clearly set forth the grounds for a formal complaint, the basis for the Commission's jurisdiction, or the Commission's authority to grant the relief requested." I've stated plainly the grounds of my complaint against Avista<sup>1</sup>, the Commission's jurisdiction over Avista<sup>2</sup>, and the authority as the regulatory authority over Avista to grant the relief requested<sup>3</sup>.

Further, as someone whose firmly held religious belief calls to follow the law as it is written, Section 3 of the Religious Freedom Restoration Act, RCW 80.28.040(1), and 480-07-110(c) go hand in hand. To do anything but rebut the allegation that I, as a righteous man, am to perform an impossibility for Avista by promising to perform in the Federal reserve system, which, according to 12 USC 411, is only for the purpose of advances between Federal reserve banks and Federal reserve agents is a substantial burden. It is unjust, unreasonable, improper and undue hardship upon me.

Is there another way I'm supposed to be phrasing things, or perhaps something I'm missing?
