BACKGROUND

- On September 23, 2002, the Commission entered its Thirty-Ninth Supplemental Order in this proceeding clarifying Verizon's obligation to make a compliance filing in accordance with the Thirty-Second and Thirty-Eighth Supplemental Orders in this docket. The Order directed Verizon to submit compliance filings no later than eight calendar weeks after service of the order.
- Verizon, on November 18, 2002 filed Advice No. 3060 containing tariff revisions for its Tariff Nos. WN U-21 Unbundled Network Elements. On November 25, 2002, Verizon amended the compliance filing to reflect that the 2nd Revised Sheet 2 in Section 5 was changed to 3rd Revised, and Nonrecurring Charges for Loop Conditioning were removed from that sheet because Loop Conditioning rates filed under Advice No. 3059, Original Sheet 4.4 replace those rates.
