SEPA is complete. The comment period ended on August 4th. No comments were submitted that caused us to change our minds on issuing the DNS for the project.

The Notice of Action Taken (NAT) process is optional, and is used "any time there is reason to believe challenges to the environmental document will be filed. Substantial controversy or known threats of challenges by project opponents are indications that judicial review is likely. By limiting appeals to a certain time period, project schedules are less likely to be disrupted."

I have prepared the NAT, and it needs to be published twice in newspapers a week apart. We plan to publish in three newspapers September 1st and 8th. There is a 21 day waiting period, which will end September 29th. That will end the opportunity for SEPA appeals.

There is no "final paperwork indicating that nothing more needs to be done to satisfy SEPA". Both Kathy Hunter and Adam Torem of the WUTC were sent the SEPA DNS and the comments. They could see for themselves that there were no comments made that would cause us to change our threshold decision to issue a DNS for the project. They will also be sent a copy of the NAT.
