Subject : Compliance with Merger Stipulations # 10 and # 20 in Docket No. UE-981627.

Dear Mr. Larson:

On October 14, 1999, the commission approved the merger between PacifiCorp and ScottishPower in its Fifth Supplemental Order Accepting Stipulations, Approving Transaction, and Granting Securities Issuance Exemption, in Docket No. UE-981627. The commission's Order required PacifiCorp to make certain compliance filings, including filings to establish network performance standards (Merger Stipulation #10, regarding baselines to the network performance standards and Stipulation #20, regarding corrective measures and improvement of the five worst performance circuits).

On June 3, 2003, in compliance with Merger Stipulation # 10, PacifiCorp filed its proposed network performance baselines for Standards 1 and 2, SAIDI and SAIFI, respectively, which the commission accepted in its Eighth Supplemental Order Accepting Compliance Filing to Establish Network Performance Baselines (July 10, 2003). On September 17, 2003, PacifiCorp filed its proposed network performance baseline for Standard 3, MAIFI, which the commission accepted in its Ninth Supplemental Order Accepting Compliance Filing to Establish Network Performance Baselines (October 15, 2003).

With two Advice Notes No. 04-08 of dates December 28, 2004, and July 28, 2005, PacifiCorp submitted two compliance filings, showing the delivery of network performance standards pursuant to the Merger Stipulations # 10 and #20 during the
