## RATE INCREASE NOTICE FOR RESIDENTIAL GARBAGE & RECYCLING IN JEFFERSON COUNTY

Dear Customer: September 30, 2023

Murrey's Disposal Co., Inc. dba Olympic Disposal has filed a request for a rate increase with the Washington Utilities and Transportation Commission (UTC). The last general rate increase was approved by the UTC June 1, 2011. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets.

If approved, the proposed rates below will become effective November 1, 2023. The rates will increase as follows:

You will receive a cart that aligns as much as possible with your current service level unless you request a different container size. The company will deliver the carts in October 2023, however the current rates will remain in effect until the approval of this rate increase.
