COMES NOW Intervenor Washington Refuse and Recycling Association
(WRRRA) and respectfully submits the following:

WRRRA has reviewed the "Status Report/Position" of the hauler
intervenors represented by Mr. Wiley and, in general, agrees with its content.
Although this matter certainly has been active for longer than one would
normally expect, there are legitimate reasons for the delay, not the least of
those reasons being the expectation of the parties that the current rule
making by the Commission may answer some, if not all, of the issues
presented here.

That being said, it is obviously time to move this docket along. WRRRA
suggests a status conference be held, at which dates certain can be set for
hearing and other procedural matters. We should have a good idea of timing
and possibly amended content of the proposed rules in a few months and,
even if we do not, this matter is too important to sit on the sidelines much
longer. We need to set a schedule and proceed, with or without amended
rules.
