Dear Mr. Whiley:

Thank you for your response to our recent letter and for providing information about your company's operations.

Staff of the Washington Utilities and Transportation Commission (commission) reviewed the information on your website (<http://www.happyhauler.com/>) and your response letter. It appears that you are now offering junk removal, cleanup and disposal. Your website describes your services by offering "Site Clean-up, Debris Removal and Disposal Service..."

Based on this information, staff has determined that Happy Hauler, LLC is providing a hauling and cleanup service for hire, which is considered private carriage and is not regulated by the commission.¹ A "private carrier" is a person who, in his or her own vehicle, transports solid waste purely as an incidental adjunct to some other established private business owned or operated by him in good faith (see RCW 81.77.010(5), enclosed)

Provided you continue to operate under your present business model and provide hauling and cleanup services, you are not subject to commission regulation.

You may not pick up residential solid waste or recycling from the curbside. These services are fully regulated in Washington. If you wish to offer solid waste collection services, you must first apply for authority as solid waste collection company. Be advised, however, that your

application would be subject to a public protest period and you would have to demonstrate that the existing solid waste company is not currently providing the services you propose to offer. The commission will only grant new solid waste authority if the existing certificated company is determined to be unfit, unwilling, or unable to provide the service.

Dear Mr. Whiley:

Thank you for your response to our recent letter and for providing information about your company's operations.

Staff of the Washington Utilities and Transportation Commission (commission) reviewed the information on your website (<http://www.happyhauler.com/>) and your response letter. It appears that you are offering junk removal, cleanup and disposal. Your response letter describes your services by stating "Happy hauler will go into a customer's home and remove items that a customer does not want any more i.e.; large appliances, furniture, etc." It also states happy Hauler cleans up yards, basements, attics, apartments and houses and disposes of the items no longer needed."

Based on this information, staff has made two determinations.

1. Happy Hauler is providing a cleanup service for hire, which is considered private carriage and is not regulated by the commission.¹ A "private carrier" is a person who, in his or her own vehicle, transports solid waste purely as an incidental adjunct to some other established private business owned or operated by him in good faith (see RCW 81.77.010(5), enclosed) Provided you continue to operate under your present business

model and provide hauling and cleanup services, you are not subject to commission regulation.

2. Staff has also determined that Happy Hauler does not reference clean-up services in its advertisement at (<http://www.happyhauler.com/>). Current commission regulations regarding advertising state that a clean-up company without a solid waste permit may advertise as a "junk Hauler" and "clean-up" or "site restoration" service. It may not advertise as purely a junk hauler. Advertising as strictly a hauler of solid waste for compensation will require a solid waste certificate.

You may not pick up residential solid waste or recycling from the curbside. These services are fully regulated in Washington. If you wish to offer solid waste collection services, you must first apply for authority as solid waste collection company. Be advised, however, that your application would be subject to a public protest period and you would have to demonstrate that the existing solid waste company is not currently providing the services you propose to offer. The commission will only grant new solid waste authority if the existing certificated company is determined to be unfit, unwilling, or unable to provide the service.

By August 2, 2011, please provide a written response as to your intention of ceasing advertising as purely a solid waste hauler, or applying for a solid waste certificate to provide this service.

Happy Hauler, LLC received a letter stating that we are advertising "solid waste collection and transportation services for hire". I wanted to explain our services and get your feedback on whether or not we are indeed required to obtain a Solid Waste Certificate from the commission.

Happy Hauler does not provide weekly curbside garbage collection. Happy Hauler is not the "Garbage Man" per say. We do not provide "neighborhood" service. Most of the items we remove are items that the "garbage man" will not take. We do not replace the regular solid waste collection services. People who use our services still need the regular weekly curbside solid waste collection services.

Happy Hauler will go into a customer's home and remove items that a customer does not want any more i.e.; large appliances, furniture, etc.

Happy Hauler cleans up yards, basements, attics, apartments and houses and disposes of the items no longer needed. We provide clean out services to apartment managers. A customer will call us if they have irregular or heavy items to remove and dispose.

We also will remove items that people have left over after a move or garage sale. We go into the home and bag or box up items, and put them in our truck. Sometimes the items are in one central location, sometimes they are strewn all around a house or yard.

We pick up furniture that people have left near apartment dumpsters, but we do not empty the dumpster of regular household garbage.

Our average Yardwaste job consists of items that are too large for a yardwaste container. We will load the items in our truck, sometimes having to cut the branches down to smaller size, we will rake and clean up all the debris in the area, leaving a clean, waste free yard.

Our average time on a job is about an hour. Again, we do not replace the regular solid waste collection service, we are more like a janitorial service.

The items collected go to various places after we collect them. We take the items that we collect to Goodwill and other charities, metal goes to recycle centers, computer parts go to another charity, appliances go to appropriate recycle center, TV's and monitor to members of Take it back network. Yard waste also goes to an independent recycle facility. All other items to a single source recycle facility.

RCW 81.77.040 States : When an applicant requests a certificate to operate in a territory already served by a certificate holder under this chapter, the commission may, after notice and an opportunity for a hearing, issue the certificate only if the existing solid waste collection company or companies serving the territory will not provide service to the satisfaction of the commission or if the existing solid waste collection company does not object.

We do not believe that applies to our work because the "territory" we work in must have a certificate holder for their regular curbside solid waste collection. We work in conjunction with the curbside collector, we do not replace them.

We want to be compliant with the law, so if we do indeed need a certificate, let us know. Also, if our advertising is misleading in any way, or if you can suggest clarification to wording so that we are compliant with the law, please let me know.

The staff of the Washington Utilities and Transportation Commission (commission) has determined that Happy Hauler is advertising solid waste collection and transportation services for hire.

In 2010, a new law (HB 2399) passed making it illegal to advertise, solicit, offer, or enter into an agreement to haul solid waste for compensation without a solid waste certificate from the commission (RCW 81.77.040). The commission will now take enforcement action against suspected illegal solid waste collection companies based on this definition alone.

The commission regulates all companies that collect and transport solid waste for compensation, over any public street, road, or highway, in Washington State. A solid waste company must have a certificate issued by the commission to provide solid waste service. Cities have the option to both collect and transport solid waste themselves or contract with private companies to provide the service within incorporated city. (RCW 81.77)

Solid waste is defined as, but not limited to, all putrescible and non-putrescible solid and semisolid wastes including, but not limited to: garbage, rubbish, refuse, swill, ashes, industrial wastes, sewage sludge, demolition and construction wastes, and source-separated recyclable materials collected from single and multi-family residences. SUBJECT: Initial Review of alleged unpermitted solid waste collector Happy Hauler, LLC

On July 8, 2011, I was searching online looking for solid waste haulers who use the internet to advertise their businesses. I used (www.google.com) and located Happy Hauler, LLC advertising on their website (<http://www.happyhauler.com>). I also located Happy Hauler, LLC advertising on the (<http://www.yelp.com/biz/happy-hauler-seattle>) website. One example of advertising by Happy Hauler, LLC, taken from their website, was the following: *"We are GARBAGE MEN, friendly and strong garbage men at that, but not necessarily the best formal dinner guests... Move debris to the curb. This cuts labor costs."* Also stated on this website under FAQ's was the following: *"Will Happy Hauler move furniture & household belongings (Moving Services)? No. Unless you are in a real jam and it's not expensive stuff."* (Emphasis added)

- There are no references anywhere on Happy Hauler, LLC's website offering a cleanup service. It appears they are advertising strictly as a hauling company according to their website.
- It also appears that, on occasion, Happy Hauler, LLC provides moving company services.
- I reviewed commission records and found no listings in either permitted carriers or regulated solid waste collection companies for Happy Hauler, LLC.
- I reviewed the Department of Ecology's records and found Happy Hauler, LLC recorded in the Transporters of Recyclable Materials list.
- I looked at the website and confirmed that Happy Hauler, LLC advertises solid waste pickup and transportation services for a fee. One example taken from <http://www.happyhauler.com> was the following: *"We initially take into consideration the volume and accessibility of the load to inform you of the cost of the Service Fee for that job..."* (Emphasis added)
(Emphasis added) Another example, taken from <http://www.yelp.com/biz/happy-hauler-seattle> stated the following: *"...Very friendly, professional and reasonably priced..."* (Emphasis added)
- The Happy Hauler, LLC website includes a contact telephone number for scheduling services. The website also provides for online scheduling of hauling services. The website lists (206) 784-0313 as the telephone number.
- On July 11, 2011, I reviewed records from the Washington State Department of Licensing (DOL), Department of Revenue (DOR) and Secretary of State (SOS). Happy

Hauler, LLC is registered with DOL, DOR and SOS. All three departments listed Happy Hauler, LLC's business and mailing addresses as 614 NW 90th St, Seattle, WA, 98117-2135.

- According to DOL, Happy Hauler, LLC has a current license under UBI #601994195. The governing person(s), according to the current license is Philip Whiley.
- According to DOR, the legal entity for Happy Hauler, LLC is Philip Whiley.
- According to DOR, the account for Happy Hauler, LLC opened on January 1, 1999.
- On July 8, 2011, I conducted an internet search using www.whitepages.com to find and confirm the current addresses for Philip Whiley. According to www.whitepages.com, Philip Whiley's address matched the mailing address on Happy Hauler, LLC's business license.

Recommendation

I recommend the commission provide technical assistance in the form of a compliance letter outlining the new law change to RCW 81.77.040, the requirements to obtain certification under the appropriate RCWs and WACs, and the possible ramifications if non-compliance continues. I recommend requiring a written response from Happy Hauler, LLC detailing the services they provide so staff can review and recommend a course of action.

Transporters of Recyclable Materials

Introduction

In 2005, Senate Bill 5788, commonly referred to as the Recycling Enforcement & Accountability Act, became law. The bill requires all transporters of recyclable materials to register with Ecology. A transporter of recyclable material is defined as: "Anyone who is paid to transport recyclable material from commercial or industrial sources over the public highways of this state, and who is required to have a common carrier's permit from the Washington Utilities and Transportation Commission to operate.

Transporters do not include:

1. Carriers of recyclable materials that they own or are buying or selling, and carrying in their own vehicle, as long as this activity is only incidental to their primary business.
2. Entities or persons hauling their own recyclables, or recyclables they purchased, in their own vehicles.
3. Nonprofit or charitable organizations collecting and transporting recyclable materials from a buyback center, a drop box, or a commercial or industrial source of recyclable materials.
4. City municipal solid waste departments or city solid waste contractors.
5. Common carriers whose primary business is not the transport of recyclable materials.

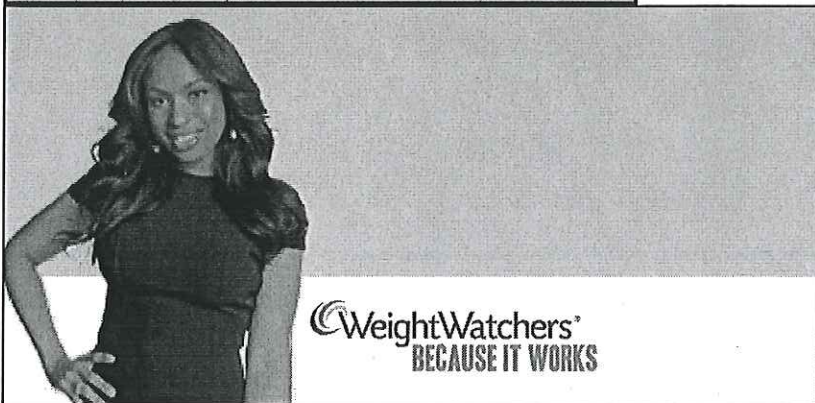


