The proposal repeals some rules that are no longer necessary, adds rules to clarify existing federal rules, which the Commission adopts by reference, and includes new rules that are more stringent than federal rules. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
