In the previous Notice, Eon Telecom, with it's OCN 839J had requested access to telephone numbering resources limited only to the Rate Center of Seattle in LATA 674 with the NPA 206.

Please accept this new Notice to allow for future expansion in the ordering process of telephone numbering resources throughout the entire State of Washington. This would include all three LATAs (672, 674 & 676) as well as all the NPAs, present and future in whatever Rate centers within these NPAs are available at the time if the new orders.
