**NOTICE OF CHANGES TO PROCEDURAL SCHEDULE**

RE: *Sandra Judd et al. v. AT&T Communications of the Pacific Northwest, Inc., and T-Netix, Inc.*, Docket No. UT-042022.

**TO PARTIES OF RECORD:**

During the telephone conference held yesterday, May 10, 2005, the Commission heard oral argument concerning AT&T's Objection to Complainants' designation of Mr. Kenneth Wilson as expert witness pursuant to paragraph 6 of the Protective Order, Order No. 02 in the proceeding. The parties agreed to the following changes to the procedural schedule to allow parties the opportunity to respond to various pleadings and motions filed in the proceeding:

**Pleadings Relating to AT&T's Objection to Complainants' Designation of Expert Witness:**

**Thursday, May 12, 2005:** Complainants' Surreply to AT&T's Reply in Support of its Objection to Complainants' Expert Designation, including a description of the topics and types of evidence about which Complainants expect Mr. Wilson to address.

**Tuesday, May 17, 2005:** Additional Response of AT&T and T-Netix to Complainants' Surreply.

**Friday, May 20, 2005:** Decision on AT&T's Objection

**Pleadings Relating to T-Netix' Motions to Stay Discovery and for Summary Determination:**

During the telephone conference, T-Netix filed electronically with the Commission its Reply in Support of Motion to Stay Discovery and Response to Complainants'

Conditional Motion to Postpone and Grant New Discovery; Affidavit of Stephanie Joyce in Support of T-Netix, Inc.'s Motion for Stay of Discovery; and T-Netix, Inc.'s Reply in Support of Motion for Summary Determination. T-Netix later filed a Motion to Strike and Declaration of Arthur A. Butler in Support of the Motion to Strike. Although not discussed during the telephone conference, parties may file pleadings in response to T-Netix's pleadings as follows:

- Friday, May 13, 2005:** Complainants' Reply to AT&T's Response Joining in T-Netix's Motions, Reply to T-Netix's Response to Complainant's Conditional Motion to Postpone and Grant New Discovery, and Response to T-Netix's Motion to Strike.
- Friday, May 20, 2005:** AT&T's Surreply to Complainants' Reply to Response to Joining in T-Netix's Motions, and T-Netix's Reply to Complainants' Response to Motion to Strike.
- Tuesday, June 7, 2005:** **9:30 a.m.** Oral Argument on T-Netix's Pending Motion to Stay Discovery, Motion for Summary Determination, and Motion to Strike, and Complainants' Conditional Motion to Postpone and Grant New Discovery. The oral argument will be held in the Commission's Hearing Room, Room 206, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive SW, Olympia, WA.

Pursuant to WAC 480-07-145(6), parties may submit the pleadings identified in this notice electronically to the Commission by 5:00 p.m. on the day established for filing, and are granted a one-day extension of time to file paper copies of the pleadings with the Commission. If the parties seek changes to the pleading schedule and oral argument scheduled in this notice, please notify the Commission in writing as soon as possible to allow for rescheduling.
