The Commission Staff has completed a fourth discussion draft of the financial records and reporting rules in WAC Chapters 480-70 (Solid Waste and/or Refuse Collection Companies), 480-73 (Pipeline Companies), 480-90 (Gas Companies), 480-92 (Low-Level Radioactive Waste), 480-100 (Electric Companies), 480-110 (Water Companies), and 480-120 (Telecommunications Companies). This revised draft reflects the previous round of written comments, and discussions we have had with stakeholders during the redrafting process. We wish to offer you another opportunity to comment before finalizing the draft for presentation to the Commission as part of a CR-102 on **Wednesday, July 28, 2004, at 1:30 p.m.**

**Interested persons may file written comments on this draft by Friday, July 16, 2004.** We will take your comments and the responses to the SBEIS survey into account when we finalize the CR-102 draft, which will be made available during the week of July 19, 2004. You will have an opportunity to comment orally to the Commission on July 28, 2004, when Staff presents the proposed CR-102 draft to the Commission.
