Summary of Change:

On September 15, 2006, Qwest will post planned updates to its Wholesale Markets Web site and Product Catalog that include new/revised documentation for LSOGs: Batch Hot Cut (BHC) V2, Billing Completion Notice (BCN) V 3, Centrex Resale Service (CRS) V28, Centrex Resale Service Split (CRSS) V6, Completion Notice (CN) V13, Customer Service Record Inquiry (CSR) V22, DID Resale (DRS) V16, Directory Listings (DL) V50, Directory Service Confirmation & Error Detail (DSRED) V8, End User (EU) V44, Hunt Group Information (HGI) V6, Listing Reconciliation (LSTR) V13, Local Response (LR) V33, Local Service Ordering – Overview (OVR) V33, Local Service Request (LSR) V53, Loop Service (LS) V29, Loop Service Number Portability (LSNP) V24, Number Portability (NP) V19, Pending Service Order Notice (PSON) V13, Pre-Order Process Guide (POP) V33, Provider Notification (PN) V3, Port Service (PS) V24, Resale Frame Relay (RFR) V13, Resale Private Line (RPL) V30, Resale Services (RS) V44, and Resale Service Split (RSS) V6; PCATS other than those referred to in the following paragraph: Directory Listing Providers Business Procedures V19; PCATs: Directory Listing Providers Business Procedures V19 and Local Number Portability (LNP) V46. 70 PCATs need to be updated to reflect the documentation changes from EDI to XML. If the change is strictly related to the EDI to XML change, Qwest has provided an attachment along with this notification that identifies the following: Document Name, Version, Type of Document (PCAT, Business Procedure), Location within the Document (Section name, etc) of the change, and the Qwest Wholesale Web site URL where the operational document can be found. This is being done so that you will not have to open and review each of the individual documents on the Qwest Wholesale Document Review site. If there are changes over and above the EDI to XML change, the normal Level 2 notification process for an IMA Release will be followed. The attachment for these changes is titled: PCATs and Business Procedures Updates for IMA Release 20.0.

In addition, specific descriptions for LSOGs and PCATs that have changes over and above the EDI to XML change are found in the attachment to this notification titled: LSOG/PCAT Updates Associated with IMA 20.0 System Release.

All updates include documentation changes associated with new OSS interface IMA Release 20.0 documentation resulting from OSS Interface CRs unless otherwise specified.

Note: Since the final technical specifications have been posted, it has been determined that additional documentation updates are required. These updates will be made with Release 20.0's Addendum 1, effective October 30, 2006. They are reflected in the attached document titled: LSOG/PCAT Updates Associated with IMA 20.0 System Release under the heading: Currently Known LSOG Updates to be Effective October 30, 2006 (Addendum 1 of Release 20.0).
