- 1 On April 25, 2013, Puget Sound Energy, Inc. (PSE or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective Tariff WN U-60, designated as the Schedule 95 “Power Cost Adjustment Clause.” PSE seeks to adjust the power cost baseline rate embedded in the Company’s electric rates. The Company’s filing would decrease charges and rates for electric service by approximately \$616,833 or 0.03 percent. This power cost only rate case (PCORC) filed is authorized by the Settlement Stipulation approved by the Commission in Dockets UE-111570 and UG-011571.
  
- 2 The Commission suspended operation of the tariffs on May 9, 2013, by Order 01 entered in this docket. PSE requests that the Commission set an expedited procedural schedule in this proceeding that allows this matter to conclude within the sixth month period and requests that the Commission enter a final order by October 25, 2013. PSE also requests, by motion, that the Commission enter its standard form of Protective Order, amended to include provisions concerning the designation of documents as “Highly Confidential.” WAC 480-07-420 and -423. The Commission, by Order 02, entered a Protective Order with “Highly Confidential” provisions in this docket on May 9, 2013. PSE further seeks an extension of time to file its general rate case following the completion of this PCORC.

3 **STATUTORY AUTHORITY:** The Commission has jurisdiction over this matter under RCW Title 80, and has legal authority to regulate the rates, services, and practices of electric utilities. The statutes that apply to this matter include RCW 80.01, RCW 80.04, and RCW 80.28 relating to rates, including but not limited to RCW 80.01.040, RCW 80.04.020, RCW 80.28.020, RCW 80.28.030, RCW 80.28.070, RCW 80.28.090, and RCW 80.28.100. The rules that apply to this matter include those within WAC 480-100, relating to electric companies.

4 The Commission will hear this matter under the Administrative Procedure Act (APA), particularly Part IV of RCW 34.05 relating to adjudications. The provisions of the APA that relate to this proceeding include, but are not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission will also follow its procedural rules in WAC 480-07 in this proceeding.

5 **THE COMMISSION GIVES NOTICE That it will hold a prehearing conference in this matter at 10:00 a.m., on Friday, May 31, 2013, in the Commission's Hearing Room, Second Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.**

6 The purpose of the prehearing conference is to consider requests for intervention, resolve scheduling matters including establishing dates for distributing evidence and workpapers, to identify the issues in the proceeding and determine other matters to assist the Commission in resolving the matter, as listed in WAC 480-07-430. **Parties are encouraged to consult informally prior to the prehearing conference to develop a proposed schedule for the Commission's consideration.**

7 **INTERVENTION:** Persons who wish to intervene should file a petition to intervene in writing at least three business days before the date of the prehearing conference. *See* WAC 480-07-355(a). The Commission will consider oral petitions to intervene during the conference, but strongly prefers written petitions to intervene. Party representatives must file a notice of appearance with the Commission no later than the business day before the conference. *See* WAC 480-07-345(2). Any party or witness in need of an interpreter or other assistance should fill out the form attached to this notice and return it to the Commission. The Commission will set the time and place for any evidentiary hearings at the prehearing conference, on the record of a later conference or hearing session, or by later written notice.

8 **THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the prehearing conference set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.**
