Re: CenturyLink's compliance with Condition No. 29 to the Joint Applicants' agreement with Commission Staff and Public Counsel, Docket UT-100820, Order 14, Appendix C

Dear Mr. Danner.

Condition No. 29 in the Docket UT-100820 merger settlement agreement between CenturyLink, Commission Staff and Public Counsel, adopted by the Commission in its Order 14 in the docket, requires the filing of customer notifications with the Commission:

Within 30 days of closing of the Transaction, CenturyLink will give individual notice to its customers explaining that the Transaction has been approved subject to certain conditions. The notice will provide UTC and company phone number for questions and will notify customers that information regarding the Transaction's approval and conditions can be obtained from the UTC website at docket number UT-100820. CenturyLink will work with Commission Staff and Public Counsel on the content of the notice.

CenturyLink commits to send notice to affected customers if any of the CenturyLink ILECs or Qwest undergoes a name change. Prior to any name change becoming effective in Washington, CenturyLink will work with Commission Staff and Public Counsel on the content of a notice informing the affected customers of the name change, if applicable.

CenturyLink will file copies of the notices(s) above with the Commission after issuance, together with a description of the manner and timing of the notice.

CenturyLink provides the following information in response to this requirement:

Attachment 1 is a copy of the notice that was sent to all legacy Qwest Washington customers via bill insert starting on April 11, 2011 and continuing through a complete billing cycle until May 10, 2011. Attachment 2 is a copy of the bill messages that were sent to all legacy CenturyLink customers starting on April 15, 2011 and continuing through a complete billing cycle until May 14, 2011. CenturyLink will also be noticing its legacy Qwest customers of the name change from Qwest to CenturyLink this summer and will provide the Commission with another notice of its compliance at the conclusion of that notification.
