
To whom it may concern:

AMENDMENT NO. 12 TO THE KIOSK SALES AGREEMENT

This AMENDMENT No. 12 (the "Amendment") to the Kiosk Sales Agreement between the parties dated March 24, 2006, as amended (the "Agreement"), is made by and between Verizon Services Corp., on behalf of itself and its affiliates listed on Exhibit A, with principal offices located at One Verizon Way, Basking Ridge, New Jersey 07920, ("Verizon") and Celco Partnership, a Delaware General Partnership, on behalf of itself and its affiliates listed on Exhibit A, with principal offices at One Verizon Way, Basking Ridge, New Jersey 07920, collectively doing business as Verizon Wireless ("Verizon Wireless").

1. This Amendment is an integral part of the Agreement. The capitalized terms used herein which are defined or specified in the Agreement shall have the meanings set forth in the Agreement. If there are any inconsistencies between the provisions of this Amendment and the provisions of the Agreement, the provisions of this Amendment shall control.

2. Section 4 of the Agreement, FEES, is deleted in its entirety and replaced with the following:

4.1 Verizon shall pay Verizon Wireless in accordance with Exhibits A and B. All payments due under Exhibit A shall be due and payable net thirty (30) days. All payments due under Exhibit B shall be due and payable in accordance with Exhibit B. Fees assessed by Verizon Wireless are at all times subject to review and modification to conform to any applicable regulatory requirements governing transactions between Verizon and its affiliates.

4.2 If Verizon disputes any invoice pursuant to Exhibit A, Verizon shall provide Verizon Wireless with written notice of such dispute and any supporting documentation within ninety (90) days of receipt of such invoice and Verizon Wireless shall investigate and report back to Verizon the results and make adjustments, as necessary, within thirty (30) days from receipt of dispute.

4.3 If Verizon Wireless disputes any item or the amount pursuant to Exhibit B, Verizon Wireless shall provide Verizon with written notice of such dispute and any supporting documentation within ninety (90) days of receipt of the Validated Report and Verizon shall investigate and report back to Verizon Wireless the results and make adjustments, as necessary, within thirty (30) days from receipt of dispute.

4.4 The Monthly Recurring Fee ("MRF") set forth in Exhibit A for each Store is based on the prior year's actual rent and other costs (such as, but not limited to, utilities, property taxes, landlord fees for incremental parking spaces, etc.) for such Store as documented by Verizon Wireless. If the Store is new construction, then Verizon Wireless shall use the actual rent and an estimate of the other costs until the annual reconciliation. The MRF shall be the basis for payment by Verizon. No later than March 31st of each year, Verizon Wireless shall review the actual expenses for each Store and present Verizon with an annual reconciliation report indicating the actual expenses for the previous twelve (12) month period as compared to the payments received from Verizon for the same period. The difference between the actual expenses and payments received will be invoiced accordingly – a debit or a credit. The actual MRF rate, as substantiated by the actual expenses incurred by Verizon Wireless, will be the basis for adjustment to the MRF on a going forward basis.

4.5 The MRF for Stores opened within a month shall be invoiced to Verizon at a prorated MRF based on the actual Store installation date and actual days in the month. The formula will be (x) MRF divided by (y) actual days in the month, multiplied by (y) actual days in the month minus (z) installation date:

$$(x + y) * (y - z) = \text{prorated MRF}$$

Example:

$$(\$60 + 30) * (30 - 15) = \$30$$

4.6 The MRF for Stores closed within a month shall be invoiced to Verizon at a prorated MRF based on the actual Store close date and actual days in the month. The formula will be (x) MRF divided by (y) actual days in the month, multiplied by (y) actual days in the month minus (z) closing date:

$$(x + y) * (y - z) = \text{prorated MRF}$$

Example:

$$(\$60 + 30) * (30 - 15) = \$30$$

4.7 The Non-recurring Fee ("NF") set forth in Exhibit A for each Store is an estimate and Verizon Wireless will invoice Verizon based on actual and documented expenses for the activity associated with that Kiosk (such as, but not limited to, installation, relocation, retrofit or removal). Verizon acknowledges and agrees that with respect to a particular Store, there may be multiple invoices for the NF over the Term based on changed requirements of the parties. If Verizon decides to exit a Store for any or no reason, the parties shall agree on the removal date and Verizon shall reimburse Verizon Wireless or pay the Verizon Wireless vendors and their respective subvendors, if any, directly, for all applicable charges related to the removal of such Kiosk(s) or Handheld PC(s) and any applicable charges related to the replacement of any and all merchandising and/or fixtures to restore the Store(s). Verizon Wireless shall provide receipts for all NF invoices submitted to Verizon for payment.

3. Section 16 f. of the Agreement is amended by deleting it in its entirety and replacing it with the following:

f. 1. Verizon shall provide Verizon Wireless with the opportunity to review all third party agent personnel (the name, home address and telephone number) before such person is assigned to a Store (the "Candidate List"). Verizon shall provide a Candidate List to VZW (via email to Consultant, Human Resources) not more than one (1) time per week and VZW shall review and provide feedback to Verizon (via email to Manager, Retail National Distribution) within two (2) business days of receipt. Verizon shall not assign to any Store any person that Verizon Wireless identifies as a former Verizon Wireless employee terminated for cause and not eligible for rehire. If Verizon does assign to a Store any such former Verizon Wireless employee who was not pre-cleared by Verizon Wireless, Verizon shall remove such third party agent personnel from the Store within three (3) days of receipt of notice from Verizon Wireless.

2. Verizon shall provide, on a monthly basis, VZW with a list of all third party agent personnel that Verizon has directed its third party staffing vendor(s) to re-assign for cause and/or not to assign to Verizon's account (the "Do Not Assign List"). Verizon Wireless shall not hire for any Store any person on the Do Not Assign List. If VZW does hire at any Store any such person on the Do Not Assign List, VZW shall remove such person from the Store within three (3) days of receipt of notice from Verizon.

3. VZW shall not hire any Verizon third party agent personnel assigned to a Store unless there is a six (6) month break in service between the end of the Verizon assignment at any Store and the commencement of VZW employment at any Store. Verizon shall not assign to any Store any third party agent personnel who was a VZW employee unless there is a six (6) month break in service between the end of the VZW employment and the commencement of the assignment as a third party agent at a Store.

g. All references in this Agreement to "day(s)" or "month(s)" shall mean calendar days or months, as the context so requires, unless specified as a business day.

h. The parties agree to implement a trial rewards program (the "Rewards Program") that consists of a Verizon funded cash payment awarded by Verizon Wireless through its "Recognizing You" program to Verizon Wireless representatives who refer customers to the Verizon personnel located at one of the designated stores in Chart 1 below (the "Rewards Stores"). Verizon Wireless shall administer the Rewards Program and shall assume responsibility for the expense of administering Recognizing You. The Rewards Program shall take place in two (2) phases: Phase 1 to run from June 1, 2009 through June 28, 2009; and Phase 2 to run from June 29, 2009 through July 26, 2009 (collectively, the "Rewards Period"). The Rewards Program shall not be renewed, extended, or expanded beyond the Rewards Period and the Rewards Stores without prior agreement of both parties and execution of an amendment. For each phase of the Rewards Period, each Verizon Wireless representative shall accrue a one-time payout ("Award") based on the representative's total referrals pursuant to Chart 2 below. Each Verizon Wireless representative shall also be eligible for a variable payout ("Bonus"), pursuant to Chart 2 below, per Unit sale of an Eligible Verizon Services that is ordered at the same time as the referral. The Eligible Verizon Services have to be captured on a valid service request which shall be initiated by Verizon personnel. If an order is not initially validated, Verizon shall, for a period of fourteen (14) days from the last date of the Rewards Period, continuously research to validate such order and reconcile and adjust any payments to Verizon Wireless. A sale of an Eligible Verizon Service shall be included in the Bonus calculation regardless of whether the Eligible Verizon Service is scheduled for installation at a subsequent date or the referred customer may cancel the service. "Eligible Verizon Services" shall include FiOS Data, FiOS TV, HSI, and DIRECTV.

Every two (2) weeks throughout the Rewards Period, Verizon Wireless shall provide Verizon updates to the initial list of Verizon Wireless representatives. The list shall include the Verizon Wireless store name, the Verizon Wireless representative's job title and employee number. Verizon shall provide the Verizon personnel assigned to the Rewards Store access to a Verizon database that retains the names of all Verizon Wireless representatives including Store name. For each referral made by a Verizon Wireless representative, Verizon shall require its Rewards Store personnel to use the database to enter the applicable referral data for the Verizon Wireless representative.

Verizon shall provide Verizon Wireless a weekly report of all referrals made by the Verizon Wireless representatives along with any applicable Eligible Verizon Services, broken down by Rewards Store and Verizon Wireless representative including a time and date stamp on each referral. Verizon shall pay Verizon Wireless through an intra-company settlement within thirty (30) days of the end of the Rewards Period, an amount equal to the total accrued rewards (Awards plus Bonuses) for the entire Rewards Period.

7. Except as expressly provided in this Amendment or Exhibits attached hereto, this Amendment shall be effective when executed by all parties (the "Amendment 12 Effective Date"), and shall remain in effect until the Agreement terminates.
8. All provisions of the Agreement not addressed by this Amendment shall remain in full force and effect.
9. The Agreement is amended to add the following new party: Alltel Wireless Holdings, LLC.

**EXHIBIT B - SCOPE OF WORK FOR JOINT MARKETING OF WIRELINE SALES IN
WIRELESS STORES**

1. This scope of work pertains to the undertaking of advertising and marketing activities that will promote and stimulate end user customer traffic to Stores for the sale and promotion of products of Verizon and its affiliates.
2. Verizon Wireless will select and procure a marketing and advertising firm or firms for the development of advertising and marketing initiatives, and supply all appropriate end user customer information as necessary for the initiative, with the cooperation of Verizon.
3. Verizon shall pay to Verizon Wireless Marketing Development Funds (MDF) in accordance with Chart 1 for those products/services sold at each Store. MDF will be paid based on new installs and new pending installs pursuant to the following, which are effective as of December 1, 2008:

3.1 Applicable Products and Services

3.1.1. Verizon shall pay MDF on all Verizon product/service offerings marketed, promoted, and sold at the Stores, except as expressly excluded in section 3.1.2.

3.1.2. Verizon Wireless is not eligible for MDF on the following Verizon products or services:

- A - VZW-VZ consolidated billing (currently known as ONE BILL).
- B - VASIP (Internet Value Added Services), which includes Back-up and Sharing, Expert Care, Premium Technical Support, Security, Starz Play, Storage, International Calling, and Games.
- C - DVR (Digital Video Recorder) which includes but is not limited to High Definition (HD) DVR/Set-top box, Home Media DVR/Set-top box, and standard Set-top box.
- D - Premium Content which includes channel line-up for FIOS TV and includes but is not limited to all Movie, International, Karaoke, WII, Premium channels, Video-on-demand (VOD), and High-Definition VOD.

Other Verizon products or services, including any Verizon products or services introduced in the future, shall not be excluded from MDF eligibility unless mutually agreed upon by the parties and memorialized by a written amendment to this Exhibit. Verizon shall provide Verizon Wireless with prior written notice of planned introduction of new Verizon products or services. In the event Verizon is unable to provide such prior written notice and/or future Verizon products or services are introduced by Verizon without agreement regarding MDF eligibility, the parties shall work together to address MDF eligibility. If such products or services are agreed to be MDF eligible, then such determination and MDF payment will be retroactive to the date such Verizon products or services were introduced by Verizon.

3.1.3. Verizon shall not pay MDF on any Verizon product/service eligible for MDF which is ordered by a Verizon customer at a location other than a Store, despite the fact that the Verizon customer subsequently changes such product/service within the same product category at a Store (i.e., a Verizon customer ordered FiOS Data at a lower speed at a location other than a Store and subsequently changes to FiOS Data at a higher speed at a Store). Notwithstanding the above, Verizon shall pay MDF should a Verizon customer at a Store order a new/incremental product/service eligible for MDF from a different product category (i.e., Verizon customer with HSI changes to FiOS).

3.1.4. Verizon shall pay MDF on any Verizon product/service eligible for MDF which is ordered by a customer at a Store, despite the fact that the customer subsequently changes, upgrades or downgrades the product/service ordered between the point of sale and the issuance of the Validated Report, regardless of whether the change, upgrade or downgrade is made over the phone, at a Store or at another location (i.e., a Verizon

customer ordered FiOS data at a lower speed at a Store and subsequently changes to FiOS data at a higher speed at any location or over the phone). If the customer changes, upgrades or downgrades the product/service ordered at a Store between the point of sale and the issuance of the Validated Report, then the MDF will be adjusted to reflect the final Verizon product/service ordered.

3.2 MDF per Unit

3.2.1. MDF shall be based on four tier levels outlined in Chart 1 and the then current Listed Product Price ("LPP") of each product/service.

3.2.2. A unit is defined as an individual product or service sold at a Store ("Unit"). If the customer purchases multiple services/products (including those contained in a "bundle"), Verizon shall pay MDF for each contributing individual product or service and not the total price of the "bundle". This excludes products and services outlined in section 3.1.2.

3.2.3. Verizon shall provide the current LPP of all contributing Units to Verizon Wireless on the first business day of each month. Verizon shall use this VZW dedicated mailbox to provide the LPP to Verizon Wireless: VzWFiOSreporting@verizonwireless.com.

3.2.4. The LPP shall be based on the annual national rate specified for each Unit, excluding any promotional or discounted rate. FiOS TV, FiOS data, High Speed Internet (HSI) and DIRECTV service Units shall be listed at the annual national price. MDF is payable to Verizon Wireless based on the LPP for each Unit regardless of whether Verizon offers or otherwise provides the customer with any introductory special or promotional price for such product or service that may include one (1) or more "free" months of service or waiver of the monthly recurring charge.

3.2.5. MDF per Unit at each tier level is as follows, effective as of December 1, 2008:

3.3 MDF Validation and Payment Process

3.3.1. For all sales at a Store made within a month (regardless of an installation date that might occur in a later month):

3.3.1.1. Verizon shall provide VZW with a report on Gross Unit Sales at each Store by the 17th business day following the end of the previous month (the "Initial Report"), which shall be in mutually agreed upon format and medium.

3.3.1.2. Verizon shall pay Verizon Wireless on Gross Unit Sales as reported in the Initial Report fifteen (15) days after the generation of the Initial Report, but in no event later than the close of the subsequent month.

3.3.1.3. Verizon shall review and update the Initial Report and shall provide Verizon Wireless with an updated report that reflects Net Unit Sales no later than thirty (30) days from the payment made in accordance with the Initial Report (the "Validated Report"), which shall be in mutually agreed upon format and medium and sent to a specified Verizon server for retrieval by Verizon Wireless.

3.3.1.4. Verizon shall charge, either a debit or a credit, to Verizon Wireless for any Units based on the difference between the Gross Unit Sales and the Net Unit Sales within forty-five (45) days after the generation of the Validated Report but no later than the close of the subsequent month. Charges, either debits or credits due to the difference between Gross Unit Sales and Net Unit Sales, shall be netted out of the prior month's Gross Unit Sales payment as outlined in section 3.3.1.2.

3.3.1.5. Sampling and Audit Rights. Verizon Wireless shall conduct a sampling or an audit of Units sold in the Stores no more than once each year. Verizon Wireless shall provide reasonable notice of its intent to conduct a sampling or an audit; provided, however, that the dates and times shall be mutually agreed upon by the parties. The duration of such sampling or audit shall be no more than one (1) business day unless otherwise agreed upon by both parties. A Verizon Wireless employee or a Verizon Wireless designated person shall travel to one (1) of the designated Verizon validation centers, as mutually agreed upon, to review the validation and reporting process of Units sold. Verizon shall allow Verizon Wireless to review the Units sold while the Verizon validation representative conducts the initial review and validation of the sale. The Verizon Wireless employee can document and request sampling screen prints of these transaction records for their internal review and documentation. Verizon shall have appropriate support during such time to answer questions and facilitate the sampling or audit review. Verizon reserves the right to withhold Customer Proprietary Network Information and Personal Information as defined by 47 U.S.C Section 222(h)(1). In the event that the sampling or audit results indicate a discrepancy in reporting and validation process that may impact the MDF payments, then the parties shall work to determine appropriate course of action to alleviate the discrepancy. If there is impact to MDF payments, then the parties agree to make adjustment - credit or debit - to next applicable or agreed upon Gross Unit Sales payment.

3.3.1.6. Validated Data File. At the same time Verizon delivers the Validated Report, Verizon shall provide Verizon Wireless with a data file (the "Validated Data File") containing all the Unit sales for each Store categorized as follows:

- (a) "Rejected Unit Sales": Unit sales that cannot be found in Verizon's systems, are deemed to have been obtained as a result of fraud or material misrepresentations, have been cancelled during the validation period, or have been rejected by Verizon for a reason corresponding with a previously issued rejection code, including but not limited to, failure to pass credit check or to clear engineering review. Each rejected Unit sale shall be assigned a rejection code. Any modifications or updates to rejection codes will be provided to Verizon Wireless prior to the start of a sales month.
- (b) "Installed Unit Sales": Unit sales that have been found in Verizon's systems and have resulted in installation of service within the validation period.
- (c) "Pending Unit Sales": Unit sales that have been found in Verizon's systems, have been assigned an installation date, and have not been cancelled or rejected during the validation period.

In the event that Verizon Wireless' review of the Validated Data File indicates a discrepancy in the reporting and/or validation process, and/or the MDF payments, then the parties shall work to determine the appropriate course of action to alleviate the discrepancy. Verizon Wireless shall submit such discrepancy results in writing, along with any supporting documentation, to Verizon within ninety (90) days of receipt of the Validated Data File.

3.3.1.7. Verizon shall include the December 2008, January 2009, February 2009 and March 2009 Gross Unit Sales together in a single Initial Report and Validated Report, which shall be provided to Verizon Wireless no later than thirty (30) days from the Amendment 12 Effective Date. Thereafter, each month's Gross Unit Sales and Net Unit Sales shall be reported and paid as described above.

3.4 Performance and Feasibility Assurance

- 3.4.1. The MDF in Chart 1 shall be reviewed for continued feasibility six (6) months following the Amendment 12 Effective Date and every six (6) months thereafter. The parties agree to consider adjusting Chart 1 and products/services excluded under Section 3.1.2 to assure continued success of the program, in which case the parties shall execute an amendment prior to the effective date of any revisions to Chart 1.
- 3.4.2. Each Store that does not meet the Standard Threshold during each of two (2) consecutive months shall be considered to be on performance enhancement status. After the third (3) consecutive month of failure to meet the Standard Threshold, the applicable Store shall be evaluated by Verizon for closure and Verizon shall thereafter pay to Verizon Wireless difference between the Standard Threshold and such Store's actual MDF attainment in each month until such Store is either closed or such Store's performance achieves the Standard Threshold.
- 3.4.2.1. A newly opened Store will be excluded from the Standard Threshold requirements for the first three (3) full months from the date sales commence. Notwithstanding the foregoing, Verizon will pay MDF for all Unit sales in accordance with Section 3.2.5 of this Exhibit at a newly opened Store during such time period.
- 3.4.2.2. The Standard Threshold for each Store shall be two thousand dollars (\$2,000.00) per month of MDF based on Gross Unit Sales during a full month.
- 3.4.2.3. Ten percent (10%) of the total number of Stores that are the lowest performing Stores are excluded from the Standard Threshold requirement; provided, however, that Verizon shall pay Verizon Wireless the MDF for all Unit sales at such Stores.

4. MDF may be used by Verizon Wireless for (a) advertising (internal or external) that promotes end user customer traffic to Stores, which may include, but is not limited to, any Verizon Wireless advertisement that identifies Verizon Wireless retail locations and that may, but is not required to, identify Stores; (b) promoting Stores and Verizon products/services through internal or external advertising; or (c) promoting the various joint products of the parties (e.g., ONE-BILL, bundles, etc.) through internal or external advertising, or other mutually agreed uses.

- 4.1. Each quarter VZW shall provide samples to Verizon of the Verizon Wireless advertisements run in the previous quarter that are eligible for MDF pursuant to Section 4 (a) above.

5. "Net Unit Sales" means the difference between the Gross Unit Sales at a Store and the total number of completed and pending products/services, that did not cancel for any reason within sixty (60) days or less after the date the customer purchased such Units at the Store as well as the total number of products/services excluded from MDF as outlined in Section 3.1 Applicable Products and Services herein.

6. "Gross Unit Sales" means the total number of sales eligible for MDF at a Store during a month.
